Information clause

According to Art. 13 paragraph 1 and 2 of the Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (**General Data Protection Regulation** (Official Journal of the European Union L119 of May 4, 2016)) I should like to inform that

- 3. We process your personal data as a part of mutual business relationships. These are personal data that may apply to your representatives, owners or employees.
- 4. We process your personal data to present a commercial offer, send information about products, promotions, to maintain ongoing contact for marketing purposes, to conclude and execute contracts for the sale of products and to perform financial settlements.

5. We may transfer your data to persons authorized by us - our employees and associates who must

have access to data to perform their duties and other recipients, e.g. insurers, carriers, entities

providing audit services, legal assistance and institutions that are entitled by virtue of the law to

request the transfer of data.

6. Your personal data will be stored for the duration of business cooperation, in order to conclude

and perform the contract and after its implementation in order to fulfill the legal obligations

imposed on the Data Administrator, for a period resulting from the legal regulations in force,

particular tax laws, including Law on income tax and the Law on the taxation of goods and services,

or/and in other cases until the business reasons cease and/or until the consent is revoked.

7. The legal basis for processing is Article 6 paragraph 1 of the above-mentioned Act.

8. Providing personal data is voluntary.

9. You have the right to request the Administrator to grand the access to personal data, the right to

rectify, delete or limit data processing, the right to object to the processing, the right to transfer

data, the right to withdraw consent at any time, without affecting compliance with the law of

processing which was made on the basis of consent expressed prior to its withdrawal.

10. You have the right to lodge a complaint to the supervisory body i.e. the President of the Office for

Personal Data Protection.
